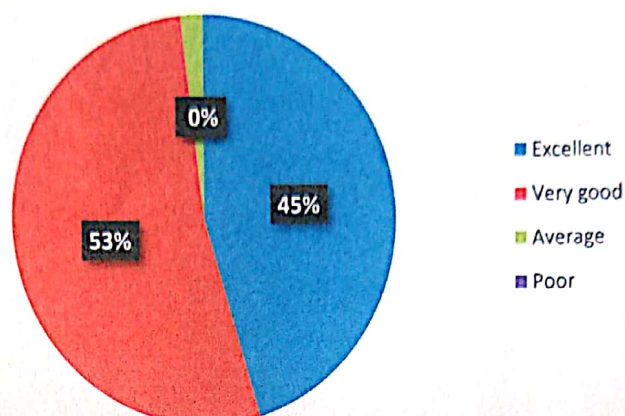
Analysis of the Feedback

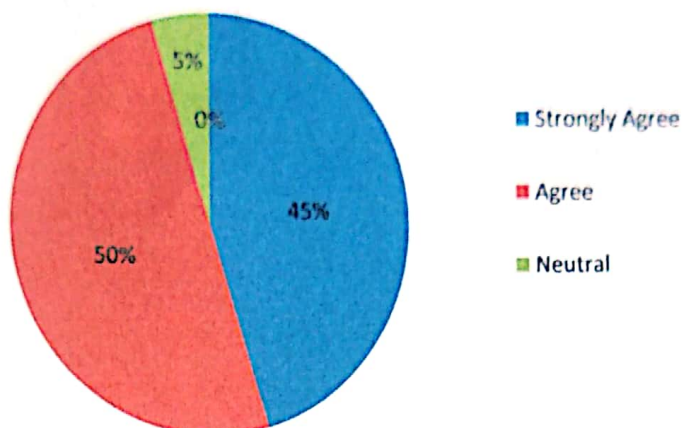


Teacher Feedback

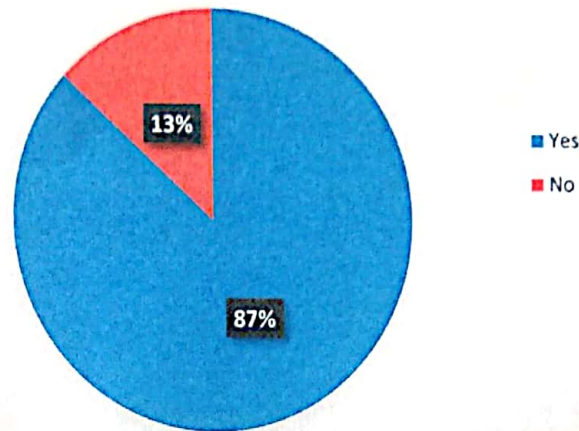


Employers Feedback

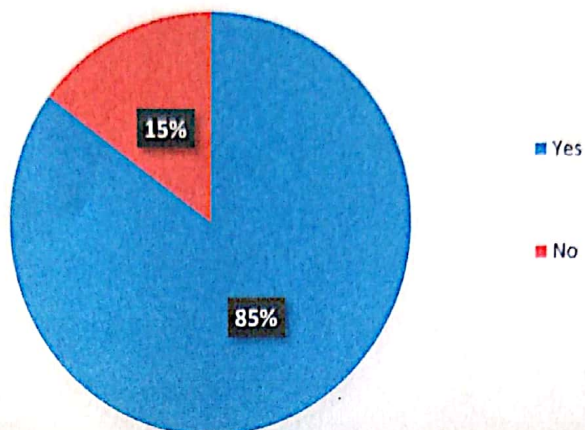


Alumni Feedback

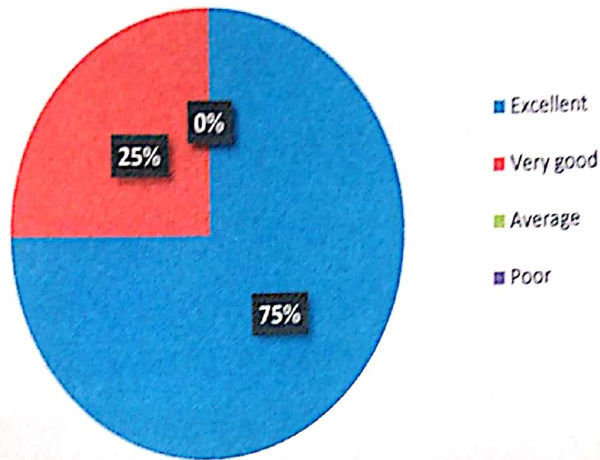


Parents Feedback
