All the Principals of Government Degree Colleges in the State are invited to the reference read above and requested to submit proposals in respect of the Lecturers working in the Government Degree Colleges concerned, those who are eligible and qualified for promotion to the vacant post of Principals in Government Degree Colleges in the State, as on 01.09.2023 for the Panel Year 2023-2024, with the following conditions, in terms of G.O.Ms.No.06, Higher Education (CE-I) Department, Government of Telangana, dated: 06.02.2023 and other Rules, so as to enable to take further necessary action in the matter.

Conditions:

- 1)** Must possess a Master's Degree with a minimum of 55% of marks of its equivalent degree or grade of B in the 7 points scale with letter grades O, A, B, C, D, E & F obtained from the Universities recognized in India.
- 2)** Must possess in Ph.D or equivalent qualification.
- 3)** An experience of 15 years of teaching as Lecturer in Government Degree Colleges.
- 4)** Pass in Accounts Test for Executive Officer, with Hall Ticket/Gazette Publication.
- 5)** Exemption of passing Departmental Tests in terms of G.O.Ms.No. 225 GAD, dated: 18.05.1999.

The Principals are instructed to check that all entries are made in Services Registers regarding qualification & eligibility, regularization of services, Leaves (EOL/ Medical / Leave not due/Dies-non etc.,) and penalty/punishment if any imposed.

The Lecturers and Principal (FAC) are informed that the Annual Confidential Reports must be signed by their Superior Officers i.e., Principal in case of the Lecturer and Concerned Joint Directors - MZ-I &

MZ-II in case of the Principal (FAC). They must be signed by those who worked during the calendar Years 2018-2019 to 2022-2023 separately.

All the above information after verification in their respective Colleges should reach to this Office within 10 days without fail from the date of receipt of this proceeding along with necessary enclosures with attestation for evidence.
