

August, 2021 NOTIFICATION FOR AWARD OF CAREER ADVANCEMENT SCHEME TO THE ELIGIBLE ASSISTANT PROFESSORS /LIBRARIANS /PHYSICAL DIRECTORS WITH ACADEMIC LEVEL 10 & 11 IN GOVERNMENT DEGREE COLLEGES OF TELANGANA STATE, UNDER UGC REVISED PAY SCALES 2016

(For the eligible employees working under the administrative control of Commissioner of Collegiate Education)

Applications are invited through proper channel from the eligible Assistant Professors/Librarians/Physical Directors with Academic Level 10 & 11 in Government Degree Colleges of Telangana State for award of Career Advancement Scheme under UGC Revised Pay Scales 2016 who fulfill the condition / qualified as on 01.07.2021.

The applicants should utilize the proformas (Annexures) enclosed herewith. They should submit the application in duplicate to the Principal concerned before the **last date i.e. 01.09.2021.**

The status of the applicants in all respects as on the date of notification will only be considered for any purpose. No requests for modification of date of eligibility will be considered from the date issuance of this Notification.

The applicants must be on the pay roles and in active service of the colleges on the date of consideration by the selection committee for selection/CAS promotions.

Applicant should fill all the columns in the prescribed application format. They may use Typed/Printed application format in "A4 size" paper which must be identical to the proforma annexed to this Notification. Application should be filled by the candidate in his/her own hand writing. No column should left blank in the application. If any column is not

relevant or not applicable, they should write against the column "NR" or "NA" as in the case. They should affix passport size photograph in the space provided in the application. The photo should be attested by the concerned college Principal. The qualification and other certificate copies are also be enclosed with the application duly attested by the Principal concerned.

Applicants should submit applications in duplicate, to the Principal of the college. The Principal under their administrative control should be consolidated and only those with minimum academic performance and service requirements for promotions to teachers & equivalent cadres in colleges in Appendix-II Table-1, Appendix-II Table-4 and Appendix-II Table-5 as the case may be & with minimum API Score in category I, II and III are to be submitted to CCE after due verification and certification as per the proforma in the Application for award of Career Advancement Scheme **before date 01.09.2021**.

The Career Advancement Scheme awards will be granted as per GO.Ms No.15, Higher Education (UE) Dept., dt.29.06.2019 and subject to Rules, Regulations and Exemptions governing the scheme and subject to modifications/clarifications and other conditions issued by the competent authority from time to time.

The Career Advancement Scheme promotions of Assistant Professors from Academic Level 10 to 11 and Academic Level 11 to 12 shall be conducted by a Screening cum Evaluation Committee as prescribed at Para 2.1.X.B, 2.1.X.D and 2.1.X.F of GO.Ms No.15, Higher Education (UE) Dept., dt.29.06.2019.

ELIGIBILITY CONDITIONS FOR ASSISTANT PROFESSOR: as per requirement for promotion from Academic Level 10 to 11 and Academic Level 11 to 12, mentioned at Appendix-II Table-1, Appendix-II Table-4

and Appendix-II Table-5, of GO.Ms No.15, Higher Education (UE) Dept., dt.29.06.2019, subject to other conditions that may be prescribed by the UGC and the University.

The last date for submission of applications by the Principal to the CCE is **01.09.2021** to put forward the candidates to the respective Screening Selection Committee, headed by the CCE.
