In reference third cited, the Departmental Promotion Committee convened on 22.06.2016 and approved the names of eligible Junior Lecturers for promotion (Recruitment by transfer) as Lecturers of Government Degree Colleges. Consequently, Sri/Smt. **S. Venkateshwar Rao**, Junior Lecturer in **BOTANY, GJC, BHEL** has been appointed temporarily under Rule 10(a) of the A.P. State and Subordinate Service Rules of 1996 as Lecturer in **BOTANY** under APCES and posted to **GDC, Serilingampally, R.R.District** in the existing vacancy at his / her request in the Revised UGC Pay Scales 2006 in the scale of Pay of Rs.15,600-39100+6000/-AGP as he/she possessed N.E.T/S.L.E.T/Ph.D.

Further, in reference third cited, he is informed that his services as Lecturer in Government Degree College are purely temporary and liable to be terminated at any time without notice and without assigning any reason what so ever for such termination.
