In reference third cited, the Departmental Promotion Committee convened on 22.06.2016 and approved the names of eligible Junior Lecturers for promotion (Recruitment by transfer) as Lecturers of Government Degree Colleges. Consequently, Sri **S.Srinivas/ Seenaiiah**, Junior Lecturer in **ZOOLOGY, GJC, Miryalaguda** has been appointed temporarily under Rule 10(a) of the A.P. State and Subordinate Service Rules of 1996 as Lecturer in **ZOOLOGY** under APCES and posted to **GDC, Malkajigiri, R.R.District** in the existing vacancy at his request in the Revised UGC Pay Scales 2006 in the scale of Pay of Rs.15,600-39100+6000/-AGP as he/she possessed N.E.T/S.L.E.T/Ph.D.

Further, in the reference third cited, he is informed that his services as Lecturer in Government Degree College are purely temporary and liable to be terminated at any time without notice and without assigning any reason what so ever for such termination.

However, it is come to notice that there is no post of **ZOOLOGY** available in GDC, Malkajigiri, R.R.District as informed by the Principal(FAC) concerned.

As there is no clear existing vacancy and even no post in **ZOOLOGY** is available in GDC, Malkajigiri, R.R.District, it is decided to modify the orders. Therefore, the orders issued in reference third cited are here by to be modified.
