Conditions :

1. The Principal is advised to approach the State Government for the appointment required number of lecturers as per the work load
2. Commerce lab to be established.
3. Library to be strengthened by procuring a minimum of five new titles / editions each in the subjects offered.
4. All the laboratories are to be strengthened as per OU norms.
5. Teaching diaries and student attendance registers are to be maintained as per norms.

NOTE: 1. Comprehensive inspection will be conducted to all the colleges in the month of December, 2011 to verify the extent of fulfillment of conditions stipulated and whether the college is functioning as per APSCHE/OU norms.

2. Candidates are to be admitted as per the sanctioned intake mentioned in the OU affiliation order and the admitted list need to be submitted by the date stipulated to the Director, Directorate of Academic Audit, OU.

3. Inspection will be conducted to the colleges that were granted New courses/combinations/additional sections during the academic year 2011-12 till the first batch of students...

GENERAL GUIDELINES:

1. Non- Compliance of the conditions laid down by the Inspection Committee within the stipulated time shall lead to withdrawal of affiliation.
2. The College should appoint teaching staff through duly constituted Selection Committee as per OU norms and also obtain University approval for the same.
3. The Management is warned not to admit the students over and above the coiling strength.
4. **As per the decision of the Executive Council if the College makes admissions over and above the permitted strength in any Course, that course of the college will be automatically disaffiliated.**
5. For Change of Premises/Management/Society/Name of the College the Management should approach the University before 31st December of each year following the guidelines issued by the APSCHE and which were communicated to your College Vide Lt.No.437/MR/H/03-04/Acad/IV-2 & 3 , Dt.08.04.2004.. Any violation in this regard will lead to penal action including disaffiliation.
6. The College is required to maintain institutional records as given in proceedings No.423/AAC/96, dt 04-05-1996 and to keep them ready for inspection.
7. The College should remit the prescribed fee towards AAF/SRF/SRCF/SWF/ IUTF /Academic records, fees etc. as prescribed by the University from time to time.

Based on the proceedings of the Secretary, APSCH, Hyderabad and on the recommendations of the University Inspection Committee which visited **Govt Degree College, Hayathnagar, R.R.Dist** on 28.08.2011, the Vice Chancellor has accorded permission for grant of provisional affiliation for starting New Courses from the academic year 2011-2012, subject to fulfillment of the conditions stipulated by the APSCH and the University Inspection Committee and general rules of affiliation.

CONDITIONS:

1. The principal is required to recruit teachers viz. two in Commerce and one each in Mathematics, Physics and Computer Science as per work load.
2. Books worth Rs. 20,000/- in Commerce and Rs.10,000/- each in Mathematics, Physics and Computer Science to be purchased for the proposed course.
3. One more Computer lab to be established with 30 systems.
4. Separate Physics Lab to be established exclusively for Degree Courses.

Further, the Management is directed to submit the compliance report for the above conditions within fifteen days along with documentary evidence wherever necessary through the University nominee on the Governing Body in the following format, failing which, the students admitted in your college will not be permitted to write the annual examinations of the academic year 2011-2012:
