Sub: Collegiate Education–Continued/Discontinued/Proposed PG Courses of Government Degree College, Patancheru for the Academic Year 2020-21-Certain Instructions/Guidelines -Issued.

Read: CCE's File. No. CCE-AC/GEN/25/2020-ACADEMIC CELL .

Commissionerate of Collegiate Education is created to promote Collegiate Education giving special attention to the areas located in Backward and Rural areas and to introduce need based courses in a phased manner. The reorganization of courses through GO.Rt.No.65 Higher Education Department dt.13.04.2018 under the chairmanship of Commissioner, Collegiate Education has increased the enrolment in all Government Degree Colleges by 43% i.e. the enrolment increased from 30,517 during 2017-18 to 43,572 * during 2019-20.

Due to the increased admissions in UG courses during 2018-19 and 2019-20, the Committee on Courses in GDCs has done an exercise on the viability of PG courses based on the availability of accommodation, infra structure and admissions in PG courses from last three academic years i.e. 2017-18, 2018-19 and 2019-20. Further the Committee has examined the possibility of proposing new PG Courses in some colleges.

The fee structure of PG courses in Government Degree Colleges shall be on par with the Private College fee structure in respective courses prescribed by respective universities. The PG Courses which are not viable in Govt. Degree Colleges due to above reasons shall be temporarily kept under sleeping mode and shall be offered as and when the college acquires additional accommodation, infrastructure and teaching resources. The PG Courses which are kept in sleeping mode for more than 3 years shall be referred to Government for closure.

The Principals who have requested for continuation of PG courses are hereby permitted to run the courses with the following instructions for running the courses in the academic interest of the under graduate courses.

- i. All the PG courses should have an intake of 60, hence Principals should make arrangement for the same in coordination with the respective universities.
- ii. All the PG Students attendance should be linked with the Biometric Attendance.
- iii. Regular Teachers can teach PG Classes only after completion of Under Graduate Workload every day in respective subjects.
- iv. The colleges should maintain Biometric Attendance for the Guest Faculty of PG Courses and the guest faculty should be paid as per the biometric attendance.
- v. The Principals shall also see that the accommodation and infrastructure grants are procured with the support of local MLA, MP, District Collector and Philanthropists to run PG courses without any disturbance to the UG accommodation and infrastructure.

The details of the PG courses proposed for Government Degree College, Patancheru are as follows:
