Vide references 1st & 2nd cited, the Government have sanctioned and released funds of Rs.75.00 Lakhs towards meeting the expenditure by the District Collector under "Crucial Balancing Fund" (CBF) for the year 2018-19.

Vide reference 3rd cited, the Principal, Government Degree College for Women, Wanaparthy has requested to sanction funds for providing 105 duel desks to Government Degree College for Women, Wanaparthy and the District Collector has endorsed to sanction funds after taking tender rate of duel desk from Gadwal or District Educational Officer, Wanaparthy.

Accordingly, Administrative Sanction is hereby accorded for the above works with an estimated cost of **Rs.17.43650 Lakhs (Rupees Seventeen Lakhs Forty Three Thousand Six Hundred and Fifty Only)** and entrusted to the Executive Agencies concerned as shown in Col.5 of the Table.

The Executive Agencies are instructed to execute the works sanctioned above and shall follow the departmental norms in vogue.


The sanctioned works shall be completed within the sanctioned amount only as no further spillover shall be allowed. The Executive Agencies shall maintain an asset Generation register for the works taken up under the Scheme "Crucial Balancing Fund". The Executive Agencies shall maintain separate cash book and accounts for the funds released under "Crucial Balancing Fund". The Executive Agencies shall submit monthly progress report for the works sanctioned under scheme in the prescribed format.

50% of the funds shall be released to the Executive Agencies on receipt of the detailed estimates and technical sanction from the competent authority. The remaining 50% of funds shall be released on production of M.Book, Photographs, relevant records and certificate of completion.

The Executive Agencies are instructed to purchase the items as per D.P.C approval rates or GEM rates.

The Executive Agencies shall furnish the utilization certificates to the Chief Planning Officer, Wanaparthy in the prescribed format soon after completion of payment is made for the connected works.

The Executive Agencies shall produce all relevant records to the audit whenever called for.
