Curricular Aspect

The staff regularly attends orientation courses with a view to upgrading their skills in the changing patterns of the syllabi and the modes of teaching. The faculty members also attend departmental meetings and conferences arranged by the Departments of the nearby Universities where curriculum design is discussed and reviewed
