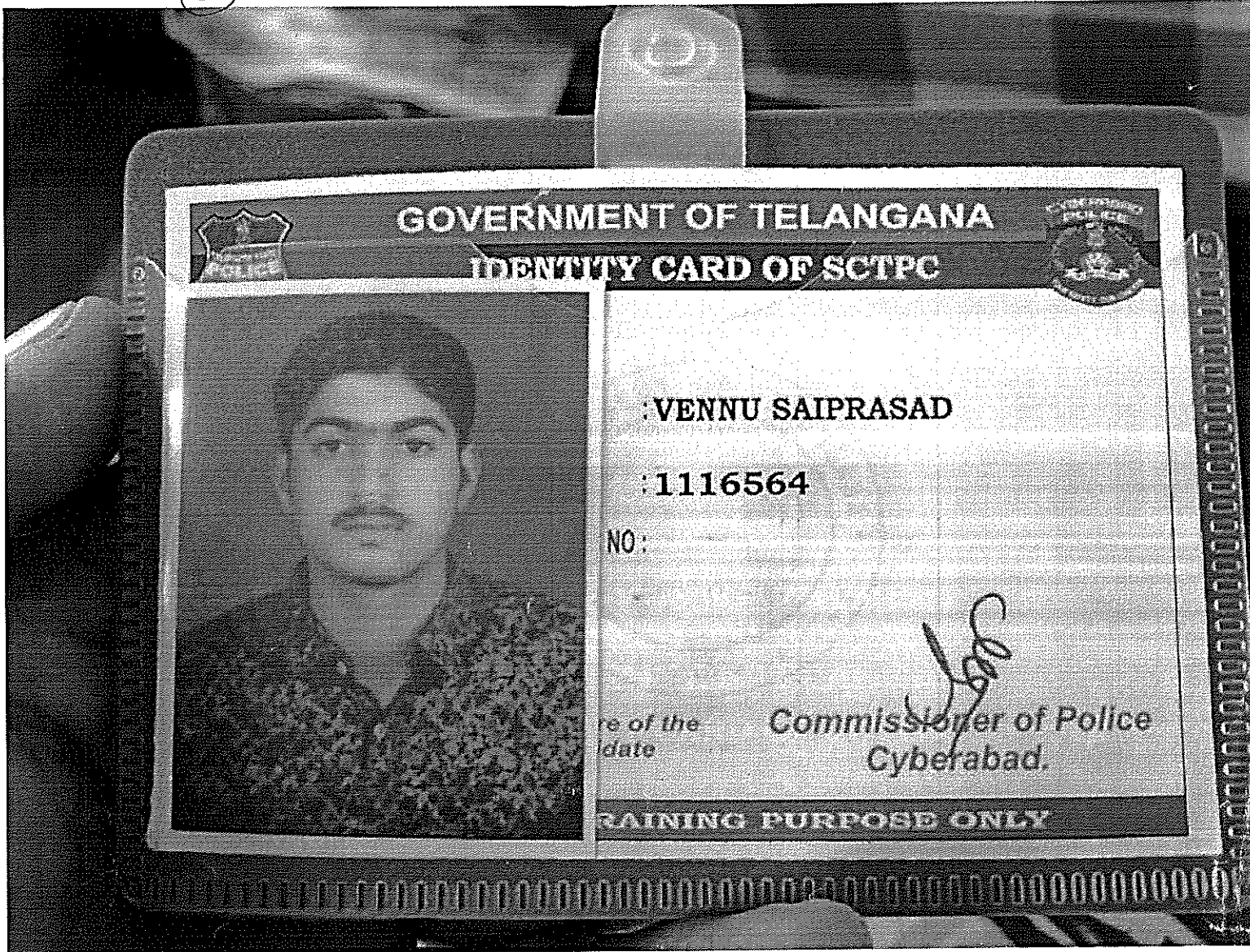
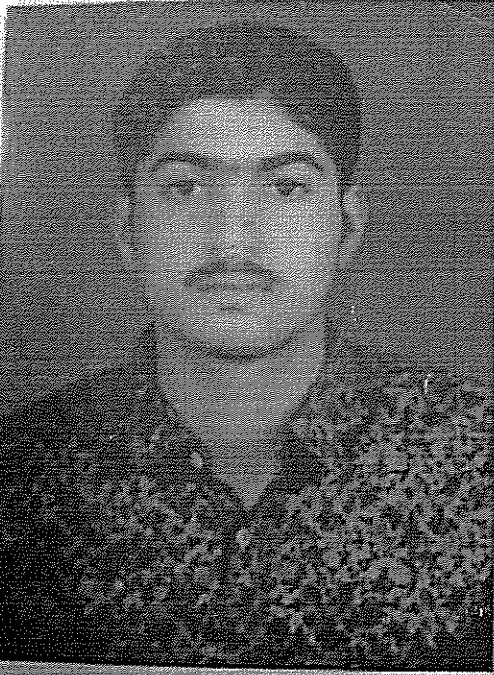

Through the references cited, S/Sri/Smt/Kum. VENNU SAIPRASAD, (Reg.No.1116564) Stipendiary Cadet Trainee Police Constable (Civil) (Men & Women) who was sent for (09) months basic induction training at CTC Nizamabad, and on successful completion (09) months basic induction training is appointed as Police Constable (Civil) at Erstwhile Cyberabad Commissionerate w.e.f. 09.10.2020 F.N and allotted General No. 9625 in the time scale of pay 16400 - 470 - 16870 - 510 - 18400 - 550 - 20050 - 590 - 21820 - 640 - 23740 - 700 - 25840 - 760 - 28120 - 820 - 30580 - 880 - 33220 - 950 - 36070 - 1030 - 39160 - 1110 - 42490 - 1190-46060-1270-49870 under Rule (16) (a) subject to the condition that his/her services are liable to be terminated at any time before declaration of his/her probation under Rule 16 and 17 of TS and Sub-Ordinate Service Rules 1996 with one month/s notice or with one month/s pay in lieu thereof. He/She is placed on probation for period of (02) years on duty within continuous period of (03) years from the date of appointment.

He/she shall be liable to serve in Police Department for a minimum period (05) years as per the agreement bond given by him at the time of undergoing induction training, failing which he/she shall be liable to repay the pay and allowance, or any other remuneration received by him/her, in addition to the amount spent by the Government on their training together with interest thereon. He/She shall be liable to serve in all the specialized units viz. Intelligence, CID, Railways, Training Institutions, Grey Hounds, OCTOPUS etc., wherever he/she is posted.


Further, he/she should occupy Govt. quarter and stay in Police lines whenever the quarters are available and allotted to him/her

He/She will be Governed by the Telangana Contributory Pension Scheme 2004, as per the orders contained in G.O.Ms.No.653, Finance (Pen-1) Department, G.O.Ms.No.654, Finance (Pen-1) Department and G.O.Ms.No.655, Finance (Pen-1) Department, Dt: 22-09-2004 respectively and the Telangana Revised Pension Rules, 1980 will not be applicable to him/her and C.P.S. contribution will be recovered from his/her pay as per rules from the date of appointment i.e. w.e.f. 09.10.2020.

The appointment order is subject to outcome of the OAs/WPs, SLPs if any pending before the High Court/Supreme Court or any court of law.

The Seniority list of Police Constables (Civil) will be communicated separately.

Consequent on his/her appointment as Police Constable (Civil) he/she is allotted to the Rachakonda Commissionerate. The individual is instructed to report before the Commissioner of Police, Rachakonda Commissionerate immediately.
