On the basis of the recommendation of the Inspection Committee and approval of the Hon'ble Vice-Chancellor the University has accorded the approval of Grant of extension of Provisional Affiliation to **GOVT. DEGREE COLLEGE, BODHAN (5007)** for the Academic Year 2019-2020, to offer courses/combinations and intake shown as below, subject to fulfillment of the specific conditions and general rules as mentioned:

Specific Conditions:

1. Biometric attendance is mandatory for both staff and students.
2. Library should be strengthened by procuring books worth Rs.25,000/- for each faculty as per new syllabus requirement.
3. All science labs should be strengthened with adequate chemicals and equipments of worth Rs.25,000/- as per new syllabus requirement.

General Rules of Affiliation:

1. It is mandatory to install CC Cameras and Biometric for both Staff and Students.
2. Fire Safety Certificate should be obtained from fire services department for college building.
3. Staff approval / renewal before 16th September, 2019.
4. Issue the appointment orders to the teachers before 24th September, 2019.
5. All the three Governing Body meetings should be conducted for each Academic Year by associating University Representative as the Governing Body Member and submit duly filled Governing Body meeting minutes proforma for details and decisions of Governing Body meeting and submit it to the office of the Directorate of Academic Audit, TU on the same day of the meeting or the very next day without fail.
 - i) First Governing Body meeting should be conducted in the month of July/August, 2019.

- ii) Second Governing Body meeting should be conducted in the month of October, 2019.
- iii) Third Governing Body meeting should be conducted in the month of February, 2020.
6. Teaching Diaries, Students Attendance Registers, Staff Attendance Registers, Acquittance Registers, Stock Registers and Accession Registers are to be maintained as per norms and are to be signed and stamped by the Governing Body Member during the Governing Body Meeting.
7. Salaries to the staff should be paid through bank A/c payee / online, deduct professional tax and submit Form-16 to IT Department.
8. Provide Girls Waiting Room with Toilets.
9. Provide potable water to all the students in each floor.
10. Arrange electrical lights and fans in each class room and lab.
11. The College should display the College Name Board prominently along with the details of the College Full Address, Phone Numbers, Website, Email-ID and its affiliation status to Telangana University.
12. The college should approach the University 15 days before expiry of the term of the Governing Body/Selection Committee Members.
13. The College should have a Website and Email-ID, Skype ID and Webcam with Headphones.
14. Teaching Staff information to be uploaded Online in Faculty Management System at College Logins.

You are therefore, directed to submit the Compliance Report on the fulfillment of (all recommendations are mandatory) the above deficiencies in the following format along with the documentary evidence to reach this office by **30.01.2020** through the University representative on the Governing Body of the College without fail.



GENERAL GUIDELINES:-

1. Non-Compliance of the conditions laid down by the Inspection Committee within the stipulated time shall lead to withdrawal of affiliation.
2. The Management is warned not to admit the students over and above the ceiling strength.
3. If the College makes admissions over and above the permitted strength in any course, that course of the college will be automatically disaffiliated.
4. For Change of Premises/Managements/Society/Name of the College the Management should approach the University before 31st December of each year following the guidelines issued by the TSCHE. Any violation in this regard will lead to penal action including disaffiliation.
5. The College is required to maintain institutional records and to keep them ready for inspection.
6. The College should remit the prescribed fee towards Common Services as prescribed by the University from time to time.
