It is also an opportunity for the students to improve their marks. The fallowing are the various plans : 1. Term wise Teaching Plan - Based on the prescribed syllabus issued by the Affiliated University term wise teaching plan is prepared. The staff members have to prepare a teaching plan in the beginning each semester and they cover the portion in accordance with their plan. The staff members are require to maintain their teaching dairies about topics actually covered match with the plan. Different committees are formed of each Academic Year. The Coordinators, Co- Coordinators and Committee Members propose action plan of various activities such as cultural programmes, Seminars/ Workshops, Tutorial Classes, Special Lectures, Academic and Industrial Visits, NSS and Sports Events within the Frame Work of the Calendar of Events issued by the university.

The objects of Society include: Developing the small villages like Palem as a model village, propagation of greenery, promotion of academic excellence in schools and colleges, providing food at least once in a day to totally uncared and unsupported old people, annadanam to feed the poor, supply of books to libraries, promoting sports, conducting free yoga classes and medical camps etc.
